ANNOUNCEMENT Regulations on delivery of import/export hazardous goods containers (IMDG) at Tan Cang - Cat Lai terminal.

Saigon Newport Corporation (SNP) would like to extend our sincere thanks to your esteemed Shipping lines/Agent/Customers for valuable cooperation and support over the past years.

Implementing the transition of delivering hazardous goods containers (IMDG) outside Tan Cang - Cat Lai Terminal (TCCL) in order to ensure safety, fire and explosion prevention of the terminal and surrounding areas, SNP hereby announce the regulations on delivery of import/export IMDG containers at TCCL as of July 1st 2024 as follows:

1. For direct import IMDG containers: TCCL will solely serve as Port of Discharge. Import IMDG containers will be transported to Final Destination after they are discharged from the vessel calling at TCCL. Therefore,

a) TCCL will not accommodate Import IMDG containers which have Final Destination at TCCL, except transshipped, transit containers or consolidated containers at Cat Lat CFS warehouse. In container packing list and manifest, Shipping lines/Shipping agents /Customers are required to declare **Final Destination**.

b) For IMDG containers with Final Destination of those being declared Tan Cang - Nhon Trach ICD or Tan Cang - Hiep Phuoc Terminal, SNP will transport (free of charge) from TCCL to the aforementioned destinations in 24 hours starting from the time the vessel departs from TCCL.

c) For IMDG containers with Final Destination being declared others, Shipping lines/Shipping agents /Customers are required to arrange transportation out of TCCL within 24 hours starting from the time IMDG containers located on the container yard. SNP will collect service charge upon the actual excess dwell-time beyond the prescribed time as follows:

• The charges are exclusive of Value Added Tax.

2. For direct export IMDG containers: TCCL only accommodate export containers at TCCL within 24 hours prior to the vessel Expected Time of Arrival (ETA) registered by the shipping lines. To drop off containers earlier than the prescribed time, Customers can drop off at other terminals or ICDs. In case Customers choose to drop off containers at Tan Cang - Nhon Trach ICD or Tan Cang - Hiep Phuoc Terminal, SNP will transport (free of charge) to TCCL for on-time loading on-board.

3. For import/export IMDG containers loaded/discharged at other seaports: TCCL will not accommodate, except transshipped, transit container or consolidated container at Cat Lat CFS warehouse.

4. Implementation time: from 00h00, July 1st 2024.
