**Regulations on delivery of import/export hazardous goods containers (IMDG)
 at ICD Tan Cang Nhon Trach**

Tan Cang Logistics & Stevedoring JSC (“Tan Cang Logistics”) would like to extend our sincere thanks to your esteemed Shipping lines/Agent/Customers for valuable cooperation and support over the past years.

Following the Announcement No.1774/TB -TCg dated June 3, 2024 of Saigon Newport Corporation’s Regulations on delivery of import/export hazardous goods containers (IMDG) at Tan Cang - Cat Lai terminal (TCCL), Tan Cang Logistics hereby announce the regulations on delivery of import/export IMDG containers at Tan Cang Nhon Trach ICD (TCNT ICD) as follows:

1. The regulations on delivery of import IMDG containers at TCNT ICD

1.1. For import IMDG containers discharged at TCCL: containers with Final Destination of those being declared TCNT ICD will be transported (free of charge) from TCCT to the TCNT ICD in 24 hours starting from the time the vessel departs from TCCL.

1.2. For export IMDG containers loaded on board at TCCL: Customers can drop off at TCNT ICD 07 days earlier than ETA for registered vessel (no later than 24 hours prior to the vessel Expected Time of Arrival (ETA) at TCCL). Containers will be transported (free of charge) to TCCL for on-time loading on-board.

2. Service charges (VAT excluded)

2.1. Service charges for IMDG containers:

a. Container handling charges

b. Surcharge for lifting laden container from yard onto customer’s truck/barge, counting from date when container is dropped off at yard.

c. *Other charges*: under Announcement No.242/TB-TCL on service charges at Tan Cang Nhon Trach ICD effective from June 01, 2024 or other effective announcement.

2.2. Infrastructure expenditure via Ho Chi Minh City seaports: The fee would be paid at the time drop off/pick up containers at TCNT ICD by customers according to legal prevailing regulation and subject to change by the Competent Authorities. The 0% VAT invoice will be issued by TCNT ICD:
